Preliminary remark

PC or block letters

If possible, please fill in the security questionnaire for the security declaration using a PC. Otherwise, please fill in the form with **block letters, using black ink** (no pencil). The form can be signed either in handwriting on a printed copy of the declaration or electronically where the competent authority offers accepts electronic signatures. If this is the case, you can use the De-Mail programme or any online applications provided by the public administration that are designed to be equivalent to written documents. In order to be able to use these services, you will need to use the eID function of the new German identity card / an electronic residence permit. Please contact your security officer if you want him/her to send you an electronic version of the questionnaire. For data processing reasons forms completed in a different way will not be accepted.

An electronic version of the completed questionnaire will only be accepted if the undersigned has given his/her consent to the security vetting in the manner described above.

Truthful and complete answers

Should you or your spouse, registered civil partner or permanent partner have been in contact with foreign intelligence services or intelligence services of the GDR¹, please inform your security officer or the Federal Office for the Protection of the Constitution in person. In order to so, please tick the relevant boxes under No. 7 and No. 14 (request for a personal meeting). The same applies if you have been in contact with any intelligence services of 'friendly states', as foreign intelligence agents often pass themselves off as members of the security services of a 'friendly' intelligence service.

Foreign intelligence services are extremely creative when it comes to "initiating contact with targeted persons and recruitment". Efforts range from creating fake social-media profiles or posting fake job advertisements in newspapers, to initiating contact in restaurants, cinemas, theatres, on holiday, and can go as far as making attempts at blackmailing. It is often difficult to recognise attempts at initiating contact and recruitment at an early stage. However, do be careful if a person

- wants to make your acquaintance or become friends with you,
- whilst also asking for information about your job, (usually starting by asking for non-confidential information) and
- whilst trying to avoid contact with other friends and acquaintances of yours (staff employed by foreign intelligence services usually use false identities and are weary of being asked questions about their origins, e.g. their parents).

This behaviour may indicate that the person may be working for an intelligence service. The same applies to persons approaching your spouse or registered civil partner or permanent partner.

The primary objective of foreign intelligence services is to engineer a situation by which a 'target person' becomes dependent on that foreign intelligence service. To this end, the target person may **initially** be given generous financial support and the member of the foreign service may initiate **personal** relations with the target person.

It is important for potential target persons to recognise any attempts at initiating contact and recruitment before any sort of dependency has been created. This is why you should contact your security officer or the Federal Office for the Protection of the Constitution if you have any suspicion that you may have been approached by a foreign intelligence service. This will help clarify the matter in a confidential setting and alleviate any doubts you have.

Ministry for State Security (MfS), General Reconnaissance Administration (HVS) of the Mfs, Reconnaissance Administration within the Ministry of National Defence (MfNV) or: Reconnaissance Unit in the MfNV; renamed in late 1989/early 1990: Office for National Security (AfNS), Intelligence service of the GDR, information centre (IZ) in the Ministry for Disarmament and Defence.

8 Personal ties with states in which there are particular security risks for persons working in sensitive areas

This applies to those states that are named by the Federal Ministry of the Interior, the German national security authority within the meaning of Section 13 (1) No. 17 Security Clearance Check Act, in the list attached to these documents.

8.1 Residency in these states

If you or your spouse, registered civil partner or permanent partner have ever been resident in a country on that list, please state the following under No. 13:

- Name of the person;
- Duration of that person's residency in the relevant state (from/to month/year);
- Address at the time (street, no., city/town, state);
- Reason why the person was resident there

8.2 Stays for travel/ other purposes

If possible, you should give a **precise** address as your destination (e.g. the name and address of the hotel).

Should you have travelled to the same place several times a year, you may summarise the relevant details like this:

"2012-2015, several visits to Moscow/Russian Federation, staying at the X Hotel, then 2-3 business trips/year visiting company Y, staying at the Z Hotel...".

8.3 Close relatives

Close relatives within the meaning of the security declaration are your

- spouse;
- partner;
- children and children's spouses and/or partners;
- parents;
- siblings and siblings' spouses and/or partners;
- spouse's/partner's parents, siblings and children.

Under this definition, "children" includes step and foster children; "parents" includes step and foster parents, "siblings" includes half and step siblings.

If you have any close relatives who live in one of the countries included in the list, please provide the following information under No. 13:

- Name, given name and address of the close relative;
- Date of birth and place of birth;
- Nature of the family relationship (e.g. brother);
- Degree of closeness of the relationship (e.g. frequent or occasional personal

visits; frequent letters or phone calls).

8.4 Other relations

If you or your spouse, registered civil partner or permanent partner have any other ties with **at least one** of the states on the list (e.g. business relations, social or cultural contacts, culture, sports, science etc.), please provide a short explanation under No. 13. The same applies to any relations with relatives who do not meet the criteria of No. 8.3, but with whom you are in personal contact.

You are under obligation to also state any relations you have with persons who are living outside their home country on official business (e.g. embassy staff).

Please provide the particulars of all the persons you have mentioned (cf. explanations for No. 8.3).

9 Contact to anticonstitutional organisations

Activities or movements are "anti-constitutional" if there is concrete evidence that the objectives pursued or the means used to achieve these conflict with the free democratic order, in part or as a whole. The most relevant anti-constitutional movements are covered by the annual Defence of the Constitution Reports, which are published by the Federal Ministry of the Interior and which can be made available to you.

If you are unable to clearly answer "No" to the question about whether you have been in contact with anti-constitutional organisations, you should talk to your security officer and/or the Federal Office for the Protection of the Constitution. This will allow you to explain the details and to explain what your current relationship with the organisation is.

10 Pending criminal proceedings including criminal investigations, disciplinary action, and criminal convictions abroad

Please indicate if any proceedings have been initiated against you or your spouse or your registered civil partner or your permanent partner. You need to mention any type of criminal proceedings (inc. under tax law) and any disciplinary action that has been taken.

You must also state any convictions under foreign criminal law.

You do not need to mention any investigations/proceedings relating to administrative offenses, nor any past criminal convictions.

11 Other

This is about any circumstances that may be used by third parties to blackmail you.

If you are in doubt, please contact your security officer or the Federal Office for the Protection of the Constitution and request a meeting. The matter will be treated confidentially.

The term "reliability assessments" (No. 11.2) is understood to refer to checks like those conducted under the Aviation Security Act or the Atomic Energy Act.

12 Reference persons

You only need to indicate reference persons if you are to be vetted under the extended security vetting process including security investigations and if you have been asked to do so by the security officer (cf. the letter you received together with the security declaration). The persons you name as reference persons should have known you personally and quite well (usually for several years). They must be willing and in a position to give details about your private life (family, leisure time) and your professional life. Family members, permanent partners, staff or mere internet acquaintances cannot be named as reference persons. Please inform the relevant persons beforehand.

Your spouse's/registered civil partner's/permanent partner's consent to security vetting:

Your spouse or registered civil partner or permanent partner can only be vetted if he or she has consented to this. As part of the process, personal data pertaining to this person will also be stored, and also stored in electronic files. Please ask him or her to consent to this by signing the relevant field in the security declaration.
