

## Auszug aus Anschreiben der French NSA zu Security Clearances

### ENGLISH VERSION

Dear colleagues,

I am honored to provide you with some information concerning security clearances.

#### ▪ **French PSC files**

On August 9th of 2021, you have received the new PSC forms (see attached) that are to be *filled by any French national who needs to access to classified information*.

Please note that from September 1st, the former PSC files will definitively be replaced by the new ones. From that date, any PSC request sent with the former PSC forms will be sent back to you.

*The former PSC files that have been sent to the French NSA before August 31st will be taken into account by our service.*

*On the first page of the new PSC files, it seems that some points need to be clarified :*

- sections 1 to 5 are to be filled by the security officer (or equivalent) of the candidate's employer
- *In part 1, « N° de demande » corresponds to the reference of the PSC request (number or name) that the security officer (or equivalent) attributes to the PSC request*
- *Following the part 5, « à remplir par l'autorité étrangère compétente » : this part is to be filled by the authority that sends the PSC request to the French NSA (national security authority, designated security authority or security office)*
- The mention « SOPHIA » that appears on the file is the name of the IT developer.

#### ▪ **« Security clearances » team of the French national security authority**

Following the reorganisation of our service, the « networks and security clearances » office has joined the « regulation and security clearances » office. It remains *your correspondent for PSC requests, PSCIS/FSCIS and requests for security information*.
